I, _____, am requesting a Meter Estimate to service a property within S.S. Water Supply Corporation (SSWSC)'s service area. SSWSC is a private, non-profit, Member-owned water supply corporation organized under Chapter 67 of the Texas Water Code.

This request is for new service on a property outside of a platted subdivision, a property in a platted sub-division for which SSWSC did not receive Capital Improvement Fees, for additional water service on a single tract of land, or for the division of any property that would therefore be subject to a Water Availability Study per our Tariff filed with the Public Utility Commission of Texas.

If this request is being submitted to comply with Wilson County sub-development requirements, please include a copy of the Non-standard Plat/Variance Application being submitted to the county by the applicant. Additionally, please include a description of the property upon which service is desired; this can include a plat or drawing that clearly shows property metes and bounds. A Warranty Deed or other legal instrument proving property ownership must be provided before work can begin.

"Full Meter Assembly" is a complete meter installation with all necessary equipment ready to provide retail water service, which includes the requirement to pay the prevailing monthly minimum service charge. "Service Tap Only" provides the capability for water service to a property, allowing for future meter installation for retail water service.

Processing Fee: **\$135.00 (Non-refundable)**. Fee will be used to complete an engineering study to determine water availability and to develop an estimate for water service. The \$135 fee will be applied to water service fees at the time that a Membership application is completed and tendered, and all associated costs are paid.

The engineering Study is normally completed within 30 days, but may take longer depending on the engineer's workload. Estimate delivery can be delivered via telephone call, email, or regular mail (_____ Check here if you wish to be called). The estimate and water availability report are only good for thirty (30) days once delivered. If the applicant does not secure service within thirty days of estimate delivery, a new \$135.00 fee and application will need to be initiated unless the applicant requests and is granted an extension. Extensions may be given in thirty (30) day increments if the applicant requests the extension prior to the old estimate expiring.

When an application extension is granted, cost increases can be added to the estimate but no additional application fee will be collected from the applicant.

Please Note: This water availability study may require the new application arising from it be categorized as a **Non- Standard Service Connection**. Some examples of this classification are areas where water service is not currently extended; areas where line size would not support additional connections and/or compliance with local, state, or federal regulations; areas where property owners are sub-dividing property; property within subdivisions where lot owners are requesting multiple meters per platted lot(s); requests for multiple commercial connections; or service to industrial applications. Non-Standard Service applicants could be required to pay for line extensions, road bores, permit fees, securing and filing easement(s), up-sizing/replacing existing water lines, and/or other system improvements to ensure adequate water supplies to meet regulatory requirements and to support the new water service being requested. These costs will be in addition to the standard connection fees shown below:

Capital Improvement Fee:	\$3570	Membership Fee:	\$100
Installation Fee:	Varies	Valves/Appurtenances:	\$185

Applicants may contact the Corporation’s General Manager to have these fees justified or explained, or the Board of Directors via an agenda item called “Member Forum” during our monthly Board meetings held every second Tuesday. The preferred payment for fees is in the form of **CASH** or **CHECK**. If paying with a credit card, there will be a 5% surcharge added to the Capital Improvement Fee to cover banking fees incurred on credit card payments.
